Rules and Regulations For Exhibitors

Move-In and Set-Up

-Exhibitor spaces will be available for set-up from 8am until 8pm on Wednesday & Thursday, July 18 and 19. Move-in hours will be strictly enforced for security purposes. **ALL EXHIBITORS MUST BE SET UP PRIOR TO 8PM, THURSDAY, JULY 19TH. NO EXHIBITORS WILL BE ALLOWED TO SET UP AFTER 8PM, THURSDAY. NO EXCEPTIONS!**

-Parking/gate passes and exhibitor credentials will be issued at the exhibit registration building located inside Gate #7. This office will be manned Wednesday & Thursday, July 18 & 19 from 8am until 8pm. **Each exhibitor will be issued one (1) on grounds parking pass (THESE VEHICLES MUST BE PARKED IN DESIGNATED VENDOR PARKING AREAS ONLY. PLEASE NOTE: Non-Display vehicles will not be allowed to park in or around display areas.)** Display vehicles cannot be moved or started until the show closes each day.

-Vendor Gate Passes: (2 passes up to 30' x 20') (4 passes 40' x 20' and up)
Additional weekend passes may be purchased at \$15 each.

-Indoor exhibitor fee covers space as well as pipe and drape. On-site contracted exhibitor decoration services will be provided by **Northeast Decorating & Exhibit Services, Inc., PO Box 607, Syracuse, NY 13209**. A list of optional services and fees offered by this contractor can be obtained by calling **(315) 471-9989**.

-Exhibitors requiring more than basic electrical service will be charged a fee. Please contact Syracuse Nationals as early as possible if a need for such services is anticipated. **(800) 753-3978**

-Exhibitor display and merchandise must remain within the confines of the contracted space. Exhibit materials must not overflow into the aisles. Distribution of literature and sales aids must be take place within the assigned space.

-Subletting of space by exhibitors is strictly prohibited.

-Booth space must be used solely by the company/person and for the products and services stipulated by the rental agreement.

-Exhibitors are required to maintain a neat and orderly appearance at all times.

Exhibit Hours

-Indoor exhibit hours are 9am until 6pm on Friday and Saturday and 9am until 3pm on Sunday. Outdoor hours are 8am until at least 7pm on Friday and Saturday and 8am until 3pm on Sunday. Outdoor exhibitors desiring to remain open after 7pm on Friday and Saturday are encouraged to do so.

Breakdown and Move-Out -

!Exhibitors will be required to remain open and operational until 3pm Sunday.

Move-out of the buildings must be completed no later than 9pm on Sunday. All trailers and outside displays must be removed no later than 5pm on Monday, July 23. **In order to protect spectators, display vehicles cannot be moved or started until the show closes each day.**
